### I. Major Responsibilities:

### 1 Community Engagement

- Ensure the participation of the community in the project implementation and regular meetings with other relevant stakeholders.
- Design the key invention to target CPAs based on the key activities and monitor the progress of the implementation
- Provide technical support to the community for monitoring system, CSO and CBO assessment, stakeholder communication system and revolving fund mechanism etc.
- Facilitate in the design and implementation of surveys and studies when required and secure participation of stakeholders
- Monitor conflicts and risks during the project implementation and identify the key responding activities to overcome and mitigate them.
- Keep track of online monitoring to ensure the up-to-date the project's and communities' database.

### 2 Project Partnership

• Coordinate the implementation of sub-grantee based on work plan and provide technical support to CSO and CBO in grant implementation and management.

- Manage the grant agreement with target CBOs and monitor the expense of agreement and support the grantees on the work plan implementation
- Provide technical support to CSOs and CBOs on development of key activities and mechanism to effectively implement work plan within the timeframe of the grant agreement
- Review and regularly update stakeholder mapping to include all potential CSOs, CBOs and partners
  to link with the project and highlight key influences of those partners
- Establish relations and keep regular contact with key partners (multi-sector, government and non-government) at local, national and regional levels (for implementation and networking/lessons sharing)

# 3 Forest Management

- Lead and coordinate the biodiversity monitoring using the cost efficiency tool (FIAT) and conduct analysis and reporting
- Regularly follow-up with community the monitoring form for the community such as harvesting data, processing activity, nursery and enrichment and update the data
- Facilitate the processing, harvesting and nursery activities of community at the target sites and other relevant stakeholders

# 4 Bamboo supply chain development

- Build the linkages of the potential SMEs with community to initiate and scale-up supply chain of bamboo commodity and analyse gaps of the project invention and propose for new approaches
- Develop the production monitoring plan for the communities and ensure the sustainable bamboo harvest staying within sustainable harvesting plans
- Identify the gaps of SMEs and community suppliers and propose for the intervention activities
- Design and input on the new business models for bamboo supply chain

### 5 Legalization of Non-Timber Forest Porduct (NTFP) supply chain

- Represent the project in meetings with government counterparts and project partners and take minutes of project meetings to promote bamboo supply chain at the target communities to be recognized by competent authorities.
- Organize regular meeting with government counterparts and other key partners to ensure smooth synergy in project implementation at the ground
- Produce bamboo harvesting plan based on data analysis of inventory and have those approved/endorsed by Forestry Administration and/or Provincial Department of Environment
- Promote the right of the CBOs in resource use by organizing the consultation meeting with different stakeholders at the community level through project work plan

- Bachelor Degree in Natural Resource Management, Environmental Science, Forestry, Rural Development, Biodiversity Conservation or other related fields.
- At least 3 years in the sector of the conservation and or community engagement in natural resource management.
