

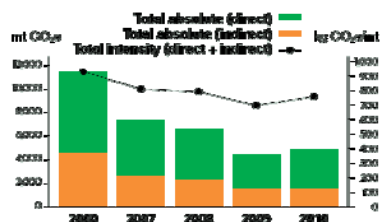

RESOLUTE IN FIGHTING CLIMATE CHANGE

Resolute Forest Products is a global leader in the forest products industry with a diverse range of products, including newsprint, commercial printing papers, market pulp and wood products. Driven by an internal commitment to sustainability, Resolute initiated the process to achieve Climate Savers membership in 2009.

Resolute has promised to fight climate change

As a global leader in the forest products industry, Resolute Forest Products strengthened its existing commitment to sustainability by joining Climate Savers in November 2011, committing to:

- A 65% reduction in absolute scope 1 and 2 emissions by 2015 vs. a 2000 baseline;
- Leading Scope 3 (indirect) emission reduction targets, including engaging significant suppliers and customers to assist them in reducing their GHG emissions;
- Supporting WWF's Energy Vision by collaborating with WWF on joint advocacy on renewable energy; and
- Strong forest management commitments, ensuring Forest Stewardship Council (FSC) chain of custody certification at all Resolute sites and increasing FSC forest certification from 18% to 80% of managed forests by 2015.

How Resolute plans to do this

In order to achieve its ambitious Climate Savers commitments, Resolute is focusing on embedding sustainability within its culture from frontline employees to senior management. The Company has recently formed a Sustainability Committee, reporting to Resolute's Executive Team, which will refine the Company's existing sustainability approach and more clearly articulate the organization's sustainability strategy.

In addition to its collaboration with WWF-Canada, Resolute plays an active role on the climate change committees of associations such as the American Forest and Paper Association, the Forest Products Association

of Canada, and the Conseil de l'industrie forestière du Québec. As a signatory to the Canadian Boreal Forest Agreement, Resolute is a member of the climate change working group, which seeks to address climate change as it relates to forest conservation.

Furthermore, Resolute is committing to working up and down its value chain with suppliers and customers, encouraging them to reduce their GHG emissions. The Company recently launched the Align™ family of papers, which offer a smaller carbon footprint than the alternative grades on the market (up to 85% smaller over the product life cycle).

Renewable energy product development

Resolute supports WWF's energy vision. To this end, it is evaluating two key opportunities to diversify into renewable energy products:

- **Commercialisation of biofuel production technologies** - Given its strategic expertise in responsible forest harvesting and access to forest biomass, Resolute is investigating various key technologies that would bring biofuels to commercial production. Potential products include second-generation transportation fuels such as ethanol and biodiesel, industrial heating oil derived from pyrolysis, as well as value-added solid fuels used for power generation.
- **Optimization of current pulp and paper processes** - Resolute is focused on reducing waste and increasing efficiency in its manufacturing processes, while at the same time seeking to efficiently manage the by-products derived from its operations. A number of opportunities are being investigated to increase the value of such by-products, such as re-manufacturing production waste into bio-based chemicals or alternative products. Other projects include diverting paper mill sludge from landfills to other beneficial uses, like compost and mine tailing remediation.

Some best practices by Resolute include:

- Taking a holistic approach to carbon reduction by committing to reduce emissions throughout its supply chain all the way to customers;
- Committing to certifying 80% of its managed forests to the rigorous FSC standard by 2015—an increase from 18%; and
- Supporting WWF-Canada's critical work through a commitment to joint advocacy and a contribution to WWF's conservation efforts.
