The Eco-Schools 7 Steps Methodology:

STEP 1 Eco-Schools Committee

STEP 2 Environmental Review

STEP 3 Action Plan

STEP 4 Monitoring and Evaluation

STEP 5 Curriculum Linking

STEP 6 Involving the Wider Community

STEP 7 Eco-Code

Schools can also choose to work on more specific areas of climate change, linking the main theme with others, such as:

- Litter
- Water
- Energy
- Transport
- Food
- Biodiversity
