I. Background

WWF has been working in Laos since the late 1980s in cooperation with the Ministry of Agriculture and Forestry. Our country programme office was first established in Vientiane in 2001. Since then, our team has grown to over 40 Lao, international and volunteer staff working on over 10 projects countrywide with offices in Vientiane, Champassak, Salavan and Sekong provinces. II. Major Functions

The Forest Programme Officer provides forest and forestry technical support to all projects and staff in the Country Office, in alignment with WWF' Forest Practice (forestry technical assistance). He/she is also the focal point of WWF Laos in the WWF International Forest Practice.



III. Major Duties and Responsibilities

- Provide technical support, including GIS services, to Project Managers and other WWF Laos' staff in all areas related to forests and forestry;
- Engage, together with Forest and Forestry Project Managers, on a regular basis with WWF Laos' Government counterparts (Department of Forestry, Department of Forest Inspection) and non-Government counterparts (e.g. local non-profit associations) to continue and build new cooperation initiatives;
- Under the supervision of the Conservation Director, be the WWF International Forest Practice Focal Point for WWF Laos and work with the regional WWF Forest Hub Team to develop strategies and programme growth;
- Assume implementation, monitoring and budget responsibilities for small grants directed at the Forest Programme and field-based projects;
- Report on the progress and achievements made against the WWF Laos 2015-2020 Strategic Plan with regards to all issues related to forests and forestry, in close cooperation with the M&E Coordinator;
- Represent WWF in relevant meetings, networks, stakeholders engagement platforms and partnership dialogues;
- Provide other operational and technical support to the Conservation Director and Country Director as required.
