We also entered into a partnership with the Tropical Forest Foundation to accelerate sustainable forest management and reducedimpact logging in Latin America, Asia, and Central At the same time, Africa. GFTN progress as measured by expanding participation forest and trade networks, forest area committed credible certification by our participants, and trading links

between supplying and purchasing participants continued steady growth.

Perhaps the most significant driver of these measures of GFTN progress were developments in Russia. Membership in GFTN's forest & trade network in Russia has grown from three in early 2003 to 17 with financial support from IKEA and USAID and technical input from the GFTN. The network's core objectives are to create market links for member products; provide technical assistance in forest management and chain of custody (CoC) certification; and assist members with communications and lobbying work with

government, NGOs, and the media. The members, which include some of Russia's largest producers of logs, sawn timber, and pulp and paper, manage 1.8 million hectares of FSC-certified forests and a combined forest lease area of over 12 million hectares. The vast majority of these hectares are now committed, through membership in the association, to credible certification over the next 10 years. In addition, there are now a significant number of new applicants to the group, including small, medium, and large producers from all regions in Russia including Siberia and the Russian Far East.

GFTN progress is by no means limited to Russia. We have a busy summer planned as we begin to implement our collaborations with the European Union and Tropical Forest Foundation and push ahead to make markets work for forests and forest-dependent people in the regions where we work. We will also roll out new ways of telling you about the progress we are making, including more frequent updates and case studies of particularly interesting projects. I hope you will have a refreshing and productive summer as well!

Tropical Forest Foundation Joins Forces with WWF GFTN

In February, World Wildlife Fund (WWF) and the Tropical Forest Foundation (TFF) entered into an agreement recognizing their mutual interest in promoting responsible forestry and providing economic opportunity by increasing the trade in responsible wood products. This partnership is designed to accelerate sustainable forest management and reduced-impact logging (RIL) practices.

"By working together, WWF and TFF will be able to accomplish more to promote responsible forest management than either of us could working alone," said Bruce Cabarle, Director of the WWF-US forest program. "The TFF RIL program fits well into the WWF Global Forest & Trade Network's stepwise approach for the achievement of certification."

TFF and WWF will collaborate on many activities, including developing pilot projects between GFTN and TFF programs in Brazil, the Guianas, Indonesia, and Central Africa that link producer group members and RIL-verified products to the market. Contingent upon its success, the pilot program will be expanded to other regions. TFF and WWF will also help develop and implement guidance for purchasing companies to support producer groups and RIL-verified products, as well as investigate ways to fund joint efforts.

Under the agreement, TFF will support the development of RIL training facilities in Southeast Asia, Latin America, and Africa and facilitate access to RIL training for production-oriented members of the GFTN and other interested parties.

WWF will encourage potential GFTN members to utilize RIL training and the RIL-verified program. Through GFTN, WWF will provide a framework and the tools for stepwise improvement in forest management, links to responsible buyers for RIL participants involved with producer groups, and communication about stepwise improvements in forest management. WWF will also actively educate its network of family offices on the key elements of the agreement and related activities and progress.

"TFF's track record of delivering on-theground RIL training and other sustainable forestry principles



combined with the World Wildlife Fund's global outreach presents a win-win opportunity for both organizations and for tropical rainforests," said TFF President Carl Gade.

European Commission Approves 3.5 Million Euro Grant in Support of WWF GFTN in Asia and Africa



The European Commission (EC) has approved a grant worth nearly €3.5 million (US \$4.2 million) over five years to support the GFTN's efforts to improve management of forest resources and prevent illegal

logging of tropical forests in Africa and Asia. The grant will strengthen the ability of corporations and communities that produce forest products to implement stepwise approaches to achieving forest certification and timber tracking systems, and to verify that their forest products are legally produced.

Funding from the grant will be used to establish six GFTN forest & trade networks (FTNs) in ten countries; develop criteria, guidelines and policy recommendations for definition and verification of legal sources of forest products; produce 60 action plans for certification and legal verification of forest products; develop practical guides for forest certification and legal verification; and increase capacity for forest certification and legal verification of forest products through training and demonstration projects. The efforts will contribute directly to the implementation of the European Union (EU) action plan for Forest Law Enforcement, Governance and Trade.

The unsustainable and often illegal harvesting of forests represents a major threat to tropical forest ecosystems and their associated biodiversity in the targeted African and Asian countries. Illegal harvesting activities also threaten the livelihoods of local communities and undermine the efforts of both private and public sector organizations to develop viable approaches to forest management. At the same time, there is increasing demand among buyers of forest products for products that are verified as legal and certified as responsibly produced.

"WWF's GFTN is the largest market-driven initiative to eliminate illegal logging and improve forest management in the world. Our membership includes 400 committed purchasers of forest products and a growing list of producers," said Darius Sarshar, GFTN's producer group coordinator. "This grant from the European Commission will help us to significantly increase capacity in Asia and Africa to bring forest products from legal and responsibly managed sources

to market."

# News from the Regions

#### **Europe**

Around 80 companies and industry organizations have signed a statement which supports the proposed EU action plan for Forest Law Enforcement, Governance, and Trade, but claim that self-regulation and voluntary measures are not sufficient to tackle the problem of illegal timber trade. The companies called upon the EC and EU governments to adopt new EU legislation which makes it illegal to import all illegallysourced timber and wood products into European markets. The statement was presented to the EC in May. Around 65% of the companies and organizations that signed are GFTN members. The company statement is in line with WWF's call for additional legislation to outlaw the import of illegally sourced/logged products to Europe. WWF is cooperating with other NGOs regarding paper issues in the European Environmental Paper Network. The aim is to develop a joint European NGO vision for the paper industry. Such a vision statement will help NGOs coordinate their efforts more effectively and present a consistent message to industry, consumers, and governments. The German association of window molding producers, Initiative Pro Holzfenster (IPH), consisting of 350 small and medium sized companies, forwarded various market enquiries with an annual value of around \$2 million per annum to GFTN's Malaysia forest and trade network (FTN) in January 2005. The queries have sparked the interest of Malaysian Wood Moulding & Joinery Council, which has invited WWF to meet with their Board next quarter to introduce the Malaysia FTN and begin identifying suitable suppliers for the German initiative. A study for the UK Timber Trade Federation and UK Department for International Development (DFID) concluded that verified legal or certified hardwoods, specifically hardwoods from outside of Europe, command price premiums of up to 30% in the UK. Certified softwoods did not command a premium because of greater availability and better distribution. Trade in certified products now dominates a large section of the UK softwood trade. GFTN's Responsible Purchasing of Forest Products has been translated into Swedish. #### **Asia**

WorldZone is officially a new participant in GFTN's Malaysia forest and trade network (FTN). World Zone is Malaysia's leading exporter of garden furniture, with customers predominantly from Europe, North America, Japan, and Australia. The company's five major suppliers are also working with WWF to conduct baseline appraisals and develop action plans related to responsible wood sourcing. The Malaysia FTN held a two-day exhibition and open forum on *Market Links Between Producer and Consumer Countries in the Timber Industry* in Sabah, Malaysia. Over 60 representatives of companies holding natural forest management units and representatives from private, government, and academic associations were in attendance. ## Asia (continued)

The Japanese companies Canon Sales Co., Inc. and Ricoh Co. Ltd., have joined GFTN Japan forest and trade network members Fuji Xerox Co., Ltd. and Mitsubishi Paper Mills Ltd., in adopting paper purchasing policies, emphasizing the need for sustainably sourced paper. GFTN Japan member Fuji Xerox Co., Ltd., in collaboration with its affiliate Fuji Xerox Office Supply Co., Ltd., ITOCHU Corporation, and Oji Paper Co., Ltd., shipped the first cargo of FSC certified woodchips to be used for copy and printer paper that Fuji Xerox will supply starting this summer. The 12,000 tons of woodchips were produced from eucalyptus trees in New Zealand owned by Southland Plantation Forest Company of New Zealand Ltd. The plantation company is partly owned by Fuji Xerox and Fuji Xerox Office Supply. The woodchips will be processed into FSC-certified paper for copy machines and printers bearing the Fuji Xerox brand for use in Japan. Contact Eishi Maezawa at emaezawa@wwf.or.jp.


A Japanese electric supply company, Tokyo Electric Power Company (TEPCO), has established a process to recycle wooden walkways into ecological paper. The process was designed in cooperation with one of the GFTN Japan forest and trade network's members, Ichise, a paper supplier. TEPCO has been maintaining wooden walkways in a Japanese national park called Oze Reserve, which is recognized as the most valuable marshland in Japan. TEPCO will use the recycled paper internally for various publications, name cards, etc. The surplus will then be sold by Ichise with the brand name "Oze". WWF Japan and Mie Prefecture Government convened a seminar and exhibition of FSC-certified products. The event was intended to promote FSC forest and chain of custody certification in the area. It attracted approximately 160 participants from various sectors including timber and plywood manufacturers, home builders, furniture manufacturers, academics, local authorities, and NGOs. WWF China participated in the first International Smart and Green Building Technologies and Products Conference and Expo in Beijing, March 28-30. In a presentation to the conference, WWF China alerted participants of the environmental and social impacts of illegal logging and unsustainable clearing and harvesting, as well as introduced the Chinese version of GFTN's *Responsible Purchasing of Forest Products*. #### **North America**

GFTN's North America forest and trade network – working in collaboration with Metafore - published a responsible purchasing guide entitled *Building a Better Business Through Responsible Purchasing*. The publication was designed as a



tool to help businesses purchasing implement policies that enhance forest management practices and eliminate illegal logging in valuable and threatened forest ecosystems around the world. Direct indirect business benefits laid are out for implementing sensible, accountable wood and paper purchasing policies including stronger supply chain relationships, enhanced brand integrity,

#### **Africa**

GFTN's forest and trade network (FTN) in Ghana has secured additional funding from the DOEN Foundation and the ICCO (Interchurch Organisation for Development Cooperation), both of the Netherlands. This funding will help facilitate effective community participation in joint forest management plans for FTN participant forests as required by Ghana forest certification standards. The project will involve the production of model social responsibility agreements (SRAs) between local communities, the state Forest Services Division, and FTN concessionaires. The SRAs will define the mechanisms for benefit-sharing of harvesting revenues, contribution of forest management operations to local employment and development, and ongoing local consultation on forest management planning. #### Latin America & Caribbean

Jagwood+, GFTN's forest and trade network for Latin America and the Caribbean, has facilitated the first sale of FSC-certified wood from Panama. The teak and amarillo from Futuro Forestal, a German-Panamanian Reforestation and Service Company, was purchased by The Smithsonian Tropical Research Institute (STRI) for its Punta Culebra Exhibition Centre, located in the Amador region of Panama City. Jorge Ventocilla, Administrator of STRI's Exhibition Centre, said that "at our Tropical Research Centre we are very conscious about the materials we are using. We believe in the necessity of certifying wood and we are going to install an educational board about FSC certification in the centre." Noemí Director Contact Pérez, Jagwood+, noemí@wwfca.org.

Jagwood+ organized a "buyers' mission" featuring products from forests under responsible management and wooden furniture certified by the Forest Stewardship Council (FSC). Participants included representatives of the companies Exportimo (Peru), Ecohout (Holland), Plywood Orozco (Nicaragua) and the Centro Mueblero, Ferretería Central and Cadena de Muebles RM (Costa Rica). Communities from the North Atlantic Autonomous Region (RAAN) of Nicaragua in the process of obtaining certification were the lead producers for this activity. The presence of high level buyers demonstrated the demand for certified products. This mission allowed the producers to recognize that their products have high quality, but that they must always improve their systems to increase sales and become competitive internationally. With technical support from WWF Peru on chain-of-custody certification (COC) preparation, and market links provided through the GFTN, Triplay Amazonico SAC, a Peruvian plywood company, successfully obtained its COC certificate and is importing certified veneer from CIKEL in Brazil. WWF Central America has recently started a new GFTN initiative in conjunction with the USAID-funded DECO-DARIEN project. The DECO-DARIEN project is managed by U.S.-based NGO ACDI/VOCA in Panama's Darien region. The initiative is designed to develop an indigenous produceroriented GFTN forest and trade network comprised of five communities in the Rio Tupiz watershed. The group will implement a forest management model to add value to the forest and provide sufficient economic returns to compete with illegal logging, improve quality of life, and protect the various ecological, cultural and social values of the indigenous communities. With funding from USAID and the WWF/World Bank Forest Alliance, WWF Central America and the GFTN recently developed a user-friendly software program to facilitate the tracking of wood from legal and/or certified forest operations. This work was designed for application in Nicaragua to comply with CITES II, FSC, and responsible purchasing policies from buyer-oriented forest and trade networks around the world. This system will be modified for use by the Peruvian forest products industry. WWF and Jagwood+ sponsored the well-known annual furniture fair, Nicamueble, in Nicaragua from February 10 to 13. More than 4,000 people attended the fair, where various companies were able to promote their certified products originating from responsibly managed forests. "Jagwood+'s participation and information stand were especially important for educating furniture buyers and producers about the urgent need to use products from forests certified for their sound management," said Noemí Pérez, Director of Jagwood+. The GFTN's community producer group in Brazil, WWF-Brazil, CTA (Centro dos Trabalhadores da Amazonia) and GFTN's São Paulo buyers group participated in a conference to discuss relationship improvement, innovative solutions for challenges in production and logistics, trading systems, and alternative species. The meeting gathered more than 35 people, consisting of buyers, producers, and NGO representatives. The community producer group shared its 2005 production season data and strategy to improve its supply capacity and services to buyers. By the end of the conference, more than 450 m3 of FSC- certified lumber were ordered by designers, architects, and other small and medium sized companies based in São Paulo. #### GFTN Notes

Fourteen new companies have joined WWF's GFTN, bringing the total participation in its forest and trade networks to 401. These participants include 31 producers and 370 buyers. The producers have committed over 12.9 million hectares of forests toward credible certification in Brazil, Nicaragua, Ghana, Indonesia, Malaysia, and Russia. The buyers have a total annual turnover of US \$30 billion in forest products. To date, GFTN has facilitated 54 market links between responsible purchasers and responsible producers of forest products.

The GFTN is pleased to announce that Kerry Cesareo assumes the position of GFTN coordinator for North America effective July 1. Kerry has distinguished herself as the GFTN's operations manager, managing complex budgets and overseeing several successful funding relationships. Global Alliance co-founder Metafore is working to give businesses the knowledge and tools they need to mesh operations with environmental metaFore and social goals. One project of Metafore, the Paper Working Group, is in the midst of testing the Environmental Paper Assessment Tool (EPAT), a Webbased tool that allows buyers and suppliers to better communicate about and measure the environmental attributes of paper. The initial prototype of the EPAT is scheduled for piloting in September by the 11 Paper Working Group companies and nine additional early adopters. Metafore also recently enhanced the Forest Certification Resource Center, an online destination for those seeking up-to-date information on forest certification.
