# I. Background

WWF has been working in Laos since the late 1980s in cooperation with the Ministry of Agriculture and Forestry. Our country programme office was first established in Vientiane in 2001. Since then, our team has grown to over 40 Lao, international and volunteer staff working on over 10 projects countrywide with offices in Vientiane, Champassak, Salavan and Sekong provinces. WWF-Laos is part of WWF Greater Mekong Programme Office, which operates in 5 countries: Vietnam, Thailand, Myanmar, Cambodia and Laos. The project helps to establish an enabling environment for civil society organizations to actively participate in natural resources management processes. The capacity building activities raise civil society organizations and community-based organizations' skills not only to exhibit quality participation, but also to monitor those processes and contribute through relevant channels whenever necessary.

### II. Major Functions

The Civil Society Project Manager supports the planning and management of project activities in SIDA-supported projects and leads the monitoring and reporting of project activities in support of all SIDA-supported projects. Tasks also include overall supervision of financial and administrative aspects of the project. He/she organizes project execution in line with programmatic objectives, engaging national counterparts and building reputation for quality design and reliable delivery. He/she is accountable for all project deliverables. He/she is also the Focal Point of the WWF International Governance Practice in Laos.

### III. Major Duties and Responsibilities

- Manage project activities, project budget and create synergies for effective management and report to the Conservation Director;
- Together with the project managers of SIDA-supported projects, and with support from the Southern Provinces Coordinator and Forest Programme Officer, prepare annual project implementation plans with project partners;
- Develop, monitor, review and update projects' activities work plan to ensure that the project attains its objectives as cost-effectively and efficiently as possible;
- Prepare monthly monitoring reports (MMR), 6-months and yearly technical reports against the approved work plan and budget plan, as per donor and Government counterpart requirements;
- Monitor and review the monthly, quarterly and annual budget expenditure reports; provide recommendations/feedback. Based on that report, together with the finance department, prepare expenditure reports vs projects' achievement for project managers of SIDA-supported projects and Government counterparts;
- Manage, build and maintain networks and partnerships on biodiversity conservation and civil society with relevant agencies, NGO partners, local authorities and local communities;
- Provide inputs to communications products and campaigns when required to ensure accurate information will be published to promote WWF activities;
- Participate in the recruitment and selection of staff under supervision and consultants:
- Be the focal point of the SIDA-supported Greater Mekong Civil Society Programme in Laos and coordinate, consult and report on programme implementation on a regular basis with the Regional Programme Coordinator;
- Be the Focal Point of the WWF International Governance Practice in Laos and participate in its relevant coordination mechanisms.
