PROJECT MANAGER

"Developing Sustainable and Responsible Tuna Longline Fisheries in Fiji" Project

WWF-Pacific, the global conservation organization is seeking to recruit a Project Manager to manage the "Developing Sustainable and Responsible Tuna Longline Fisheries in Fiji" Project and will report directly to the Programme Manager, Sustainable Fisheries and Seafood. The project is funded by New Zealand's Partnerships for International Development Fund and WWF.

The position will be based in the WWF-Pacific Office at 4 Ma'afu St in Suva, Fiji.

Required Qualifications and Experience:

- A degree in Marine Science, Marine Affairs, Development Studies, Governance or relevant environmental science or social sciences. Post-graduate qualifications desirable.
- Minimum 6 years of project-management experience working in a related field, such as Tuna fisheries management, environmental conservation, sustainable development, or international development.

Required Skills and Competencies:

- Excellent people skills, able to work effectively with a diverse team of people and build a unified team.
- Strong co-ordination and networking expertise, able to draw on the experience, skills of others rather than micro-managing, allowing support to the team in recognizing opportunities for connecting the project with other events, platforms, people who can help elevate delivery and ensure the project's longevity and sustainability.
- Strong project management experience and organizational skills able to guide the project, ensure a high standard of delivery to the New Zealand Aid Programme, and ensure that information flow among the team in WWF Pacific and WWF New Zealand is maintained.
- Experience of effective and successful project management of large public sector grants.
- Excellent verbal and written communication skills for representing the project at events and preparing quality reports.
- A strong monitoring, evaluation and learning background with expertise and processes for evidence-based reporting and building a learning and evaluation culture within WWF-Pacific.
- An enthusiastic, creative, solutions-oriented personality able to energize the project team, think outside of the box in terms of solving problems and creating new ideas within the team.
- Experience of working in the Pacific region and Fijian context is essential.
- Understanding of the Marine Stewardship Council (MSC) criteria and its application and/or Sustainability experience is preferred.
- Experience with monitoring in fisheries is preferred.
- Knowledge of the Fiji Offshore Fisheries Management Act and its regulations, Western and Central Pacific Fisheries Commission and Conservation Management Measures is desirable.
- Commit to participate in WWF's Heath & Wellbeing programme as it strives for a healthier, happier and more productive workforce.
